
Invitation to Sponsor a Lunch & Learn Session

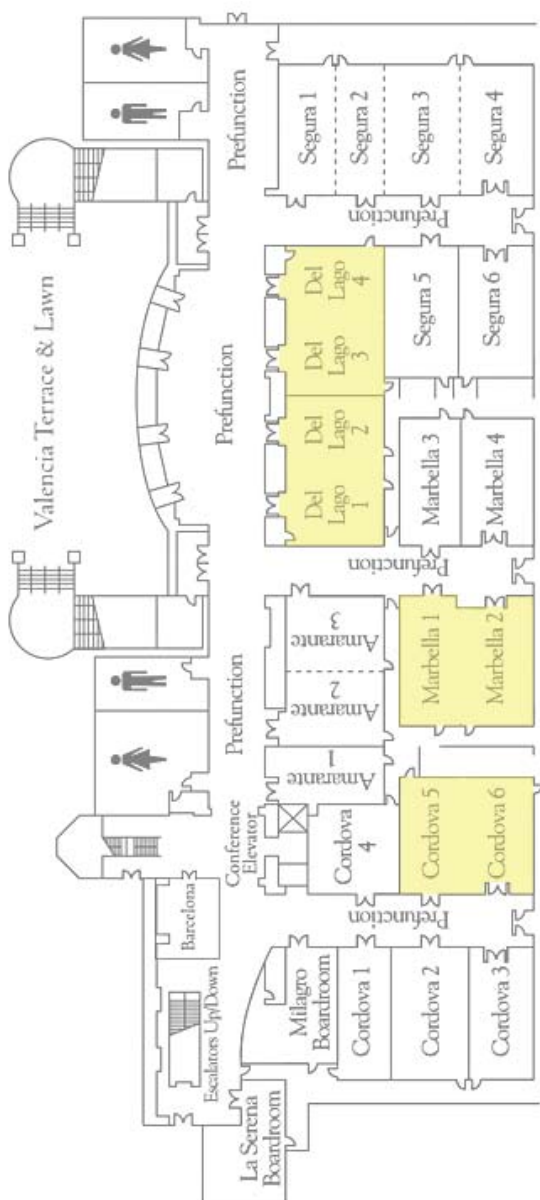

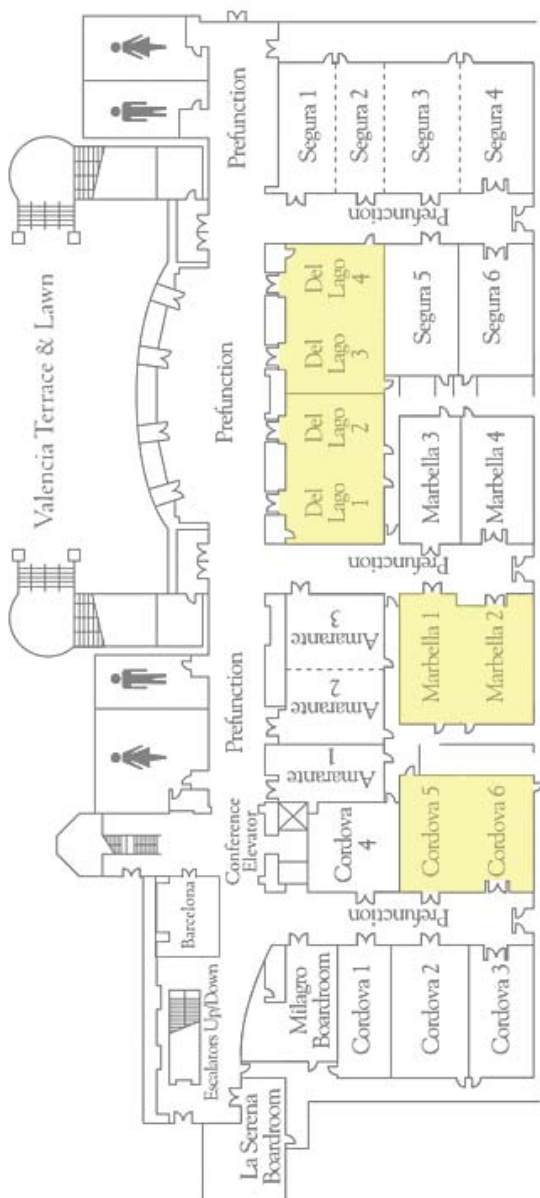

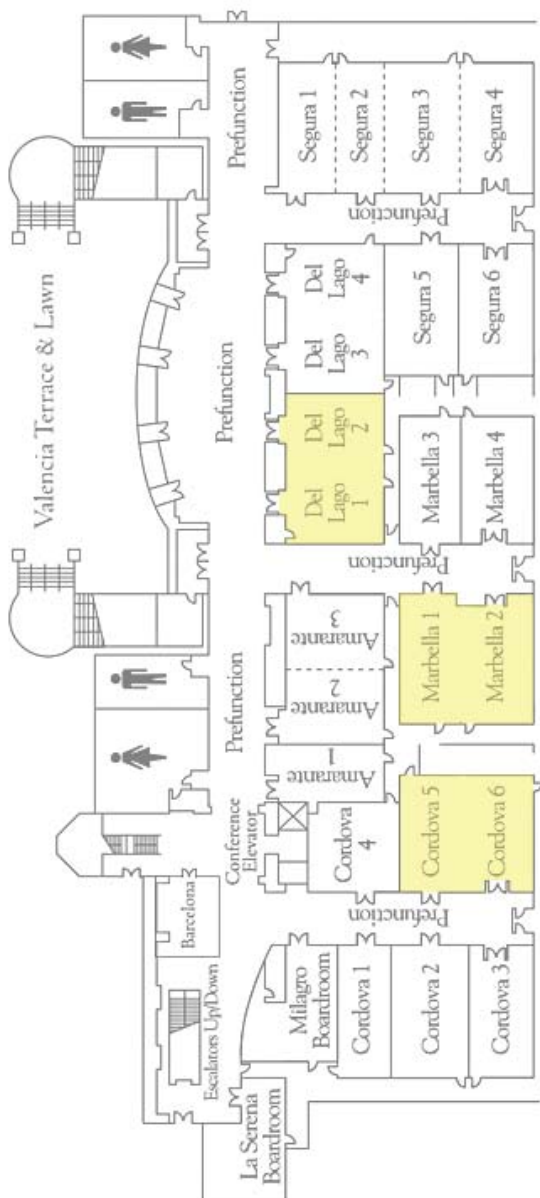
